

## Parallel grants from Barncancerfonden

Barncancerfonden has restrictions regarding parallel grants for an individual grant holder. The restrictions are presented in Table 1. Parallel grants are defined as grants with overlapping project periods. The restrictions are applicable for the main applicant. To be a co-applicant on a grant is not a restriction from applying yourself.

<sup>2</sup> Barncancerfonden supports a maximum of two (2) parallel grants per grant holder.

<sup>3</sup> The parallel grants must address different research ideas.

<sup>4</sup> Grant holder of a KP grant is allowed to apply for another KP grant if the application refers to a clinical study, where the main applicant has been appointed as PI by relevant health care planning group.
